Every teacher is required to help on either Theory Testing or Performance Evaluation Days. Required Time of Teacher Help is based on the number of enrolled CM students on November 10, 2018. Students withdrawing from the CM program at a later date DO NOT CHANGE teacher's working hours.

Number of Students Enrolled	Required Time of Teacher Help
1-5 students	5 hours or 1 session
6-10 students	10 hours or 2 sessions
11-15 students	15 hours or 3 sessions
16-20 students	20 hours or 4 sessions
21-25 students	25 hours or 5 sessions
26-30 students	30 hours or 6 sessions
30+ students	35 hours or 7 sessions

In compliance with CM State Council rules section 5.6, "CM Teachers who do not pay the Non-Work Fee by **November 13, 2019**, shall be disqualified from participating in subsequent CM Evaluations until the Non-Work Fee has been fully paid. For Non-Work Fees paid after the Branch deadline, CM Teacher will be ineligible to participate in the immediately following CM Year. For example, if Branch sets deadline of November 13, 2018 and CM Teacher pays Non-Work Fee on November 15, 2018, CM Teacher cannot participate in CM in the spring of 2019, and must wait until the fall of 2019 to enroll students again for CM Evaluations occurring in the spring of 2020."

HOWEVER, substitutes will be considered IF you notify the Branch Chair before you turn in your Teacher Help Form. The CM Committee MUST APPROVE the substitute and his/her qualifications. The Branch Chair will let you know if your substitute is accepted. If you or your substitute does not complete the assigned job(s), you will be charged \$250 fee per every session unfilled OR risk not being eligible to enroll your students for future CM until fee is paid.
